OFFICIAL RULES

3. Giveaway Period

Entries will be accepted **online only** from **Monday**, **June 30th**, **2025 at 12:00 AM EST** through **Wednesday**, **July 10**, **2025 at 11:59 PM EST**.

4. How to Enter

To enter, submit a story through the official Hudson Square Storyline web portal.

- Entry link will be accessible via the @HudsonSquareNYC Instagram profile and the postcards distributed between June 30th to July 10th.
- Only one (1) story entry per person is permitted. Duplicate entries will not increase your chances of winning.

5. Entry Requirements

Submitted stories must be original, personal, and align with the theme of meaningful moments in or around the Hudson Square community. Content that is incomplete, off-topic, or inappropriate may be disqualified at the discretion of The BID.

6. Prizes

A total of **10 winners** will each receive a gift bundle featuring **\$40 in gift cards** to a combination of local Hudson Square retailers: Maman, Westville, Shake Shack and Wonder. Prizes are non transferable and may not be redeemed for cash. Substitutions may be made at the discretion of The BID in the event a listed prize becomes unavailable.

7. Odds

The odds of winning depend on the number of eligible entries received during the giveaway period.

8. Winner Selection and Notification

Winners will be selected at random by The BID and notified via email by **Friday**, **July 18**, **2025**. If a selected winner does not respond within five (5) business days, cannot be contacted, or fails to meet eligibility requirements, an alternate winner may be chosen.

By submitting a story, entrants grant Hudson Square BID the right to use all or part of the submission in the development of public art installations, without additional consent or compensation, unless prohibited by law.

The BID reserves the right to cancel, suspend, or amend the giveaway in the event of unforeseen technical issues or other factors that compromise its fairness or integrity. The BID may disqualify any participant who tampers with the entry process or violates these rules.
